Section 3: Levy of Taxes

There is hereby levied a tax at the rate of forty five and one half cents (\$0.57) per one hundred dollars (\$100) valuation of property as listed for taxes as of January 1, 2017, for the purpose of raising the revenue listed Ad Valorem Taxes 2017-2018 in the General Fund Section 1 of this ordinance. This rate is based on a valuation of property for purposes of taxation of \$131,754,035 and an estimated rate of collection of 97.6%.

Section 4: Special Authorization of the Budget Officer

- a) The Budget Officer shall be authorized to reallocate amounts between the functional areas listed above without limitation and without a report required.
- b) The Budget Officer shall be authorized to execute transfers for contingency appropriations, not to exceed \$5,000. Notification of all such transfers shall be made to the Town Board at its next meeting following the transfer.

Section 5: Utilization of the Budget Ordinance

This ordinance shall be the basis of the financial plan for the Town of Pilot Mountain municipal government during the 2017-2018 fiscal year. The Budget Officer shall administer the Annual Operating Budget and ensure the staff and elected officials are provided with guidance and sufficient details to implement their appropriate portion of the budget.

Section 7. Copies of this Budget Ordinance

Copies of this Budget Ordinance shall be furnished to the Clerk, Board of Commissioners, Budget Officer and Department Heads to be kept on file by them for their direction in the disbursement of funds.
